#### 1. Convene

Mr. Carson reported that the Board of Directors renamed the Annual Project Excellence Award in honor of Woodward L. "Woody Vogt", past GBA President, and Fellow who dedicated his time and knowledge to GBA's missions over the past decades. Mr. Carson encouraged the member firms to apply for the Woody Vogt Annual Project Excellence Award.
